Dr. Islam is interested in qualitative and mixed-methods approaches to studying differential patterns of risk associated with substance use and structural levels of stigma among sexual and gender minority populations. Her most recent published work pivots towards young people who co-

use tobacco, cannabis, and alcohol.



Andre Luiz Oliveira da Silva, PhD received his doctorate from Escola Nacional de Saúde Pública Sergio Arouca in 2019 with a specialization in public health. Dr. Oliveira da Silva joined the CTCRE in June 2022. As the Tobacco Center's first Briger Fellow, he anticipates spending one year in the Tobacco Control Research Fellowship both gaining from our faculty's expertise and sharing his rich experiences in tobacco control research from his homeland of Brazil. Dr. Oliveira da Silva will be mentored by Stella Bialous, DrPH, FAAN, also from Brazil. Both researchers have worked for a long time with the WHO Framework Convention on Tobacco Control and tobacco control polices.

### Peter & Devon Briger Fellowship for International Candidates

In 2019, we were honored to receive a generous contribution by Peter and Devon Briger making it possible for the CTCRE to fund another Fellowship. Our Briger Fellowship is dedicated to research in global tobacco use that can energize education and policy to end the tobacco epidemic. A Briger Fellow is not required to be a US Citizen/Permanent Resident, allowing us to emphasize trainees with international potential. Finally, we are able to introduce our first Briger Fellow!

Andre Luiz Oliveira da Silva, PhD, joined the Tobacco Center on June 1, 2022. Thankfully, he was willing to relocate from his home in Brazil and is making a big splash in our Center with his magnetic personality and his enthusiasm for tobacco control research. He launched our academic year of fellows' talks with his presentation "Smoke signals from the south: tobacco regulation in Brazil" and he will present at our annual "It's About A Billion Lives" symposium, which will be in person in January 2023.

Additionally, shortly after Dr. Oliveira da Silva joined us, the Board of the Directors of the Brazilian Regulatory Agency, ANVISA, unanimously agreed, to maintain Brazil's 2009 regulation of e-cigarettes, heated tobacco and other electronic smoking devices. The decision was based on a comprehensive state of the science report that Andre and his colleagues prepared on the regulatory and public health impact of these products that followed a series of public hearings starting in 2017. The report concluded that within the Brazilian context, there was no public health benefit to treat these as consumer products. Civil society and health professional organizations

showed up in support of ANVISA in the strongest possible way. "Dr. Oliveira da Silva and his colleagues were under immense pressure from the industry, which had initiated this review of the regulation to begin with", said faculty mentor Stella Bialous. "With this re-affirmation it will be easier to enforce the regulation".

Tanner Wakefield, BA, joined the Center for Tobacco Control Research and Education in June 2015, as an Associate Research Specialist. Before coming to work at the CTCRE he earned his Bachelors in International Studies-Political Science at the University of California, San Diego. While at the Center, he produced a voluminous report on the history, politics, and status of tobacco control in Louisiana. Wakefield has also produced three articles regarding tobacco and cannabis control. His research interests are focused on public health advocacy, corporate influence and interference, as well as political systems." We are excited that his latest publication, co-authored by mentors Stanton Glantz, PhD and Dorie Apollonio, PhD, has received so much attention — the altmetric score is currently at 41!
